Entry fee 2.001,- Kč, for the KCHVO-members discount 1.000,- Kč. The Entry fee has to be paid by the set date and as follows the instructions announced in an Accepting confirmation which you will get after your registration and only if you are chosen. Don't pay the Entry fee before you get the Accepting confirmation!

Veterinary conditions:

- All participating dogs have to be healthy.
- They have to be accompanied by a Pet-passport and be rabies-immune according to § 4 paragraph 1, letter f) of the veterinary law Nr.166/199 Sb.
- Dogs from the EU and third countries have to be accompanied by a Pet-passport and meet the conditions of Europe Parliament Order Nr. č. 998/2003 dated 26th May 2003.

General regulations:

- Trial is held in any weather.
- The judging according to the valid Exam rules for All-round trial for pointers with CACT

- Dogs and handlers who don't meet the general conditions for attendance of the trial by the valid Exam rules are not allowed to take part in this event.
- Every handler has to present a dog-pedigree and a Pet-passport with a confirmation of the valid anti-rabies vaccination.
- Dogs, whose owner/handler is not able to prove it's identity, are not allowed to take part in this event.
- The organiser is not responsible for the loss or death of the dog or for any damage caused by the dog.
- Awarding of all titles follows the rules of FCI, ČMKU, ČMKJ and KCHVO.
- Only the weimaraners (regardless their age), who are registered in in the FCI-recognised breed-books, are allowed to enter this event.
- There is a capacity of 24 weimaraner participants, no more than 10 foreigners.
- The organiser stipulates the right to shortlist the applicants.
- Any competitor who gets a mark 0 is allowed to continue till the end of the trial, but will not meet the total placings.
- In the case of any protest the complainant has to pay a deposit of 1000,- Kč, which is refundable only in the case that the protest has been entered with merit.
- The handler is under the obligation to arrive on time, in a huntingwear and with his own shotgun. There will be a spear shooter available for every foreigner participant or participant without a hunting licence. The participant bears the costs of it.

Accommodation, transport and meals: The organiser provides for the accommodation of the judges, honourable presidium and organization board in the centre of the event. Other participants provide for the accommodation themselves.
